

TERMS AND CONDITIONS FOR THE BOSCH BUY ONCE BUY BOSCH ELK BUILT-IN PROMOTION.

Please read this Promotion terms and conditions (“Terms and Conditions”) carefully. Participation in this Promotion (*Buy Once. Buy Bosch with ELK*) will constitute your agreement to comply with these Terms and Conditions, which is limited to the purchase of selected Bosch built-in appliances, during the promotional period. If you do not agree with these Terms and Conditions, please do not participate in this Promotion. This Promotion is only available while stock lasts. The Promotion is managed by BSH Home Appliances (BSH) (“**the Promoter**”), Registration number: 1985/05742/07 and Easylife Kitchens Management (Pty) Ltd (ELK), registration number: 1995/000678/07 (“**Organiser**”).

1. This promotion is valid from 15th March – 30th June 2026 or while stocks last.
2. This promotion is available at Easylife Kitchens Showrooms based in South Africa and for clients who live in the republic of South Africa only.
3. This promotion is specific to the Bosch brand, the selected organiser and applicable Bosch products, for purchases made during the promotional period only as set out by these terms and conditions.
4. Clients that qualify for the promotion agree that contact information be shared by ELK for the use of the gift delivery, by a BSH representative.

The Promotion:

5. A client that purchases 6 (six) Bosch Home Appliances, from a selected range of built-in appliances (listed in clause 8), will receive a free Bosch Kitchen Machine (MUM9B34S27) to the recommended retail value of R 12 999.
 - 5.1 The purchase must include at least 1 (one) built-in cooking appliance (as listed in clause 8).
6. The free Bosch Kitchen Machine model number MUM9B34S27, is available while stocks last. Should stock not be available, no other substitute, replacement or similar product to a similar value will be issued.
