

- 1. The competition will start on 5 May 2025 and close at 17h00 on 30 June 2025 ("competition period").
  - 2. The competition is open to all residents of South Africa, Lesotho or Namibia that are over 18 years of age, and excludes the employees of Easylife Kitchens (Pty) LTD, Absa Bank Limited ("Absa Bank") and the respective advertising, media and PR Agencies, as well as the family members, consultants, directors, associates and trading partners of such organizations and persons.
